Dear Parents:

Parking on school grounds is a privilege extended to seniors; however, the number of parking spaces is limited. Students' names are placed on a waiting list when there are no longer any spaces available. No parking permits will be issued to students who still owe textbooks, materials or fines. Parking privileges will be governed by the eligibility and attendance policies. **If your child received three (3) or more failing grades on his or her fourth quarter report card, he or she is ineligible to obtain a parking spot according to the school's policy.**

1. Every student driver must present a valid NYS senior driver's license (Class D) and car registration with this application.
2. **Every student must exercise extreme caution when entering and leaving the parking area. Excessive speeding or reckless driving is prohibited and may result in a suspension and/or loss of driving privileges.**
3. Under no circumstances may a student go to his/her car during the school day without a written pass from the high school office.
4. Excessive absences, lateness [five (5) times per quarter – excused or unexcused], cutting of classes, and/or failures may result in a suspension and/or loss of driving privileges.
5. Students will park in the numbered parking space assigned to them.
6. All New York State Traffic Rules and Regulations pertaining to driving and auto maintenance will be in effect. Students must always yield to school buses. **School buses always have the "Right of Way."** Never cut in front of any bus when entering or leaving the school grounds.
7. The owner of the shopping center will not permit students to park in that lot, and cars may be towed if parked at their establishment.

On a quarterly basis, a lottery system will be used this year to distribute the parking spaces available for seniors. In order to be eligible for the first quarter lottery, a student must present a **valid NYS senior driver's license, car registration and this signed permission form** to Mrs. Grodotzke in my office **Wed., August 19 through Tuesday, August 25, 2020 (except Friday, August 21st) between the hours of 9:00 AM and 1:00 PM.** Upon entering the high school, **all students will be required to wear face masks and have their body temperature taken** as a screening procedure for symptoms of COVID-19. Any student with a temperature above 100 degrees or expresses any other physical symptoms of the virus listed by the Center for Disease Control will be prohibited from entering the building. Students who are missing required information at this time may be eligible for the next lottery.
