Ms. Wilson had one last question concerning the retirees. She asked if anyone knew the total amount of years of service between all of those retiring. Her answer was 131 years of dedicated service to the students and community of Rocky Point School District.

Dr. Ring introduced resident Patricia Sparks as a person who always has kind words for the individual who is retiring. He announced before we leave the superintendent's report part of the agenda, he would like to invite Ms. Sparks to the microphone.

Ms. Sparks read from a prepared statement honoring those individuals who would be retiring in the near future and also mentioned her appreciation for William Purcielli and Joseph Nowaski from Buildings and Grounds who both recently retired.

Mr. Nofi: Thank you. Mr. Nofi stated that the Board would now be moving to the formal part of the agenda. He asked if anyone in the audience had something to discuss, they should come up to the microphone.

Speaker #1: Mr. Tom Reilly gave a package of papers to the Board trustees in reference to the cul de sac he and his family live on, the blind spot the bus has approaching the stop and changing from a 66 passenger bus to a 35 passenger bus. He briefly explained some of the items that we included in the package: a list of 32 other cul de sacs, safety issues.

Mr. Reilly also mentioned that he had a meeting with Dr. Ring and Mr. Hilton and there was no assurance that the 35 passenger would replace the existing bus. He continued by saying that this summary was the product of what he had started two years ago and we owe it to our kids and residents. This was the fifth Board meeting that he has attended and he believes it is a very rational, logical plan.

Mr. Nofi: The Board greatly appreciates the tremendous amount of work that went into this. Obviously we will need to corroborate and confirm your work. We did not make any changes because of the risk. We will review this and it will be on our agenda for next month's meeting. We will have an answer for you on June $20^{\rm th}$.

Speaker #1: If anyone has any other questions in reference to this, please let me know and I would be happy to answer them.

Ms. Heggers: I live around the corner from you so I know the area you are talking about. Has the bus gone up the hill in winter with ice and snow?

Speaker #1. They use inclement weather stops during the ice and snow.

Ms. Heggers: How far is the new stop from the old stop?

Speaker #2: It is down by the firehouse. We carpool and drive the children to the stop.

Speaker #1: You cannot stand on the corner and use the road as a pass way.

Speaker #3: Four years ago a student couldn't get up the steps and slid under the bus. You do not see any traffic till the peak of the road. There are ten students involved.

Ms. Heggers: Are all ten students in the same school?

Speaker #1: No. They are in different schools.

Dr. Ring: The Board of Education acts as a Board. They will consider it at the next meeting and render a decision.

Mr. Nofi: Thank you.

Mia Brennan, MS student: Her and fellow classmate Kenny Schick would like to share their thoughts about mandatory lunch periods.

Kenny Schick, 8th grade class president: Kenny read a prepared statement as a representative of his classmates about how the Board has passed a rule restricting students to one elective and mandatory lunch periods for the entire student body. He expressed that the students were extremely displeased with this decision.

Dr. Ring: This is not a school board rule. It comes from the superintendent. We will have no layoffs and a limited staff. We do not have the available seats in the electives. This rule went to the guidance staff at the high school also. Ms. Wilson will explain this further.

Ms. Wilson: She explained in part that a guidance counselor calls the 8th grade as well as high school students down to go over their schedule. During the summer we will compile a list of students and look at the courses available. We will start with the 12th graders and go down the list to fill the spots. The full details will be on the web of how we will fill the spots.

Speaker # 6 – student: I need to take an elective class in order to get a regents diploma?

Ms. Wilson: Go back to your guidance counselor and contact me. Speak to the counselor and find out what electives are available.

Mr. Nofi: Thank you. We have limited resources going forward. We fully recognize your concern and we are trying to meet as many requests as possible.

Kenneth Schick: Thank you for hearing us.

Casey Heely: Also spoke about the mandatory lunch period and electives for ½ year. In addition, she questioned AP classes and lunch.

Dr. Ring: I would have to look at your schedule. Minimum enrollment is 15 students and if there is not 15 or more the class may be cancelled.

Adam Trilling, Travis Wheeler and Casey Heely: Read a prepared statement regarding the journalism curriculum and the change from theory to application and the fact that the newspaper would be done after school. They did not understand why the course had to be changed.

Dr. Ring: I do read the *Eagle Eye*. He read the article on electives. This is a resource issue. What do we keep or remove? My goal is for students to get something rather than nothing. It is also my goal to keep the newspaper but we will need to do this as a club, as has been the practice previously.

Mr. Nofi: We need to recess now to accept the budget/trustee votes. I will reconvene and come back. Please come back when we are finished.

Jerome Vessichio: I will only take 1 minute of your time. He suggested naming the soccer field after Al Ellis, former teacher and coach. He mentioned Mr. Ellis' years of coaching and service to the district and how Mr. Ellis left here on bad terms with the athletic director. This would be a great way to have Mr. Ellis come back to Rocky Point.

Dr. Ring: I appreciate the recommendation and we will look into it.

Mr. Nofi: At this time, we need to recess so that we are able to receive the budget votes. I will reconvene the meeting when we are finished. Please feel free to come back and ask questions. However before we recess, it gives me great pleasure to announce the names of those teachers who will be granted tenure. The following teachers will be receiving tenure: Katerina Daly – French; Deborah Elcik – Special Education; Jacqueline Hunt – Speech and Language; John Mattia – Physical Education and Health; Guy Reid – Science and Treewolf West – Art. Thank you and congratulations to all.

PERSONNEL

Upon the motion made by Diane Burke and seconded by Kathleen Heggers, the following resolution was offered:

BE IT RESOLVED, that upon the recommendation of the Superintendent of School, the Board of Education accepts the attached Personnel changes.

Mr. Nofi: We will now recess to accept the budget/vote results.

Upon the motion made by Diane Burke and seconded by Kathleen Heggers, the following resolution was offered:

BE IT RESOLVED, I move that the Board of Education recess this meeting at 9:10 PM in order to accept the budget vote and election of one (2) Board of Education trustee.

All in favor – Motion carried 5-0.

Meeting reconvened at 9:37 PM.

Mr. Nofi: We will open up the microphone to anyone who has questions or comments.

Dr. Pickenberg: First of all congratulations to all. He was curious of robotics and what will happen to it going forward in the middle school. He has been mentoring the students.

Mr. Nofi: Inquired with Mr. Pickenberg as to whether or not he had that conversation with the Middle School.

Dr. Ring: I supported Robotics. The District Office and teachers spent a lot of time researching what three other schools did. The start-up budget would be approximately \$50,000 and \$10,000 a year to run the program. We would need two advisors and \$50,000.

Dr. Pickenburg: I mean Lego's.

Dr. Ring: Do you mean Lego league moving to full robotics?

Dr. Pickenburg: I will support the school and be the advisor.

Dr. Ring: I also support this.

Dr. Pickenburg: We pride ourselves in the science fair at the Brookhaven Laboratory but why doesn't the JAE participate.

Dr. Ring: This matter was sent back to the shared decision making team and they did not move it forward. You can bring it back to the shared decision making team.

Dr. Pickenburg: Huntington school district teaches students Spanish for first two years they are in school. Can we do this?

Dr. Ring: We will need to look into this.

Speaker #7: Read a prepared statement. Thank you to the candidates and the Board members. We have a special interest in kids and are facing tough challenges. We trust that you will do best to prioritize and balance their interests. We will respectfully watch.

Mr. Nofi asked that the remaining resolutions be passed as one resolution.
