SUPERINTENDENT'S REPORT

Principal's Reports:

Michael Bowler - Rocky Point High School Assistant Principal announced:

- All seniors attended a workshop on "Making College Count" which provided a practical approach to succeeding after high school.
- Over 100 of our juniors attended the Spring College Fair at the Smithtown Sheraton.
- Employment day will be May 26th, at Suffolk Community College. Ms. McKibbin is running workshops for students dealing with resume writing, interviewing skills, and how to dress for an interview.
- The Guidance Summer Box is full of information on programs that are available to high school students
- The High School Spring Concert is May 20th at 7:30PM in the Auditorium.
- 310 students from Rocky Point will be performing at a NYSSMA solo competition on June 4^{th} & 5^{th} at Longwood HS. This is the largest group from Rocky Point to attend this competition.
- The Jazz Ensemble concert is June 8th at 7:30 PM.
- This year's Junior Prom will be held on Saturday, May 22nd in the High School. The theme is "A Night of Fantaseas." The room will be decorated in an under the sea motif. We are expecting 200 guests.

WHEREAS, It is the plan of a number of public school districts in Nassau/Suffolk Counties, New York, to bid jointly on Food Products and Supplies for the 2004-05 school year;

WHEREAS, The Rocky Point UFSD is desirous of participating with other districts in Nassau/Suffolk Counties in the joint bidding of the commodities mentioned above as authorized by General Municipal Law, Section 119-0 and,

WHEREAS, The Rocky Point UFSD wishes to appoint a committee to assume the responsibility for drafting of specifications, advertising the bids, accepting and opening bids, reporting the results to the boards of education and making recommendations thereon; therefore,

BE IT RESOLVED, that upon recommendation of the Superintendent of Schools, the Board of Education of the Rocky Point Union Free School District hereby appoints the Long Island School Food Service Directors Association Cooperative Bid Committee to represent it in all matters related above, and,

BE IT FURTHER RESOLVED, that the Rocky Point Union Free School District Board of Education authorize the above-mentioned committee to represent it in all matters leading up to the entering into a contract for the purchase of the above-mentioned commodities, and,

BE IT FURTHER RESOLVED, that the Rocky Point Union Free School District Board of Education agrees to assume its equitable share of the costs of the cooperative bidding, and

BE IT FURTHER RESOLVED, that the Rocky Point Union Free School District Board of Education agrees (1) to abide by majority decisions of the participating districts on quality standards; (2) that unless all bids are rejected, it will award contracts according to the recommendations of the committee; (3) that after award of contract(s) it will conduct all negotiations directly with the successful bidder(s). - Mr. Gerardi responded that it was digitally monitored.

- Mrs. Johannson also wanted to thank Mr. Knapp for the fabulous concert that he put on at JAE. Also all
 the field trips, and she has gone on all of them this year, from both FJC & JAE, have been great. The
 science museum, the aquarium...
 - She would also like to mention that she went through this school system many years ago and would like to especially thank Mr. Bowler who she had as a teacher and always remember what a wonderful teacher and person he was. Good luck in your retirement. You will be missed at Rocky Point.
- Mrs. Murray asked what was going on with the buses especially the doubling up on Bus A. It seems over
 the past two weeks or so the buses have been overcrowded. The regular driver was sick, the sub told a
 sick child to put his head out the window and he was sick all the way to school. She didn't put the air
 conditioning on one day when the weather was very hot and her daughter became ill.
- Ms. Thalen asked if she called the District Office. Mrs. Murray said she did and spoke to Jennifer who then in turn contacted Laidlaw.
- Ms. Bonner asked how long has this been happening.
- Mrs. Murray said the past two weeks.
- Mr. Bilyk responded that Laidlaw told us the overcrowding was a result of all the rain and game postponements, class trips, absent drivers etc. Unfortunately, this was after overcrowded already occurred. The district was just as upset. We have been in contact with Laidlaw so that this problem will not happen again.

- Mrs. Murray said that she went to the District Office and she called Laidlaw and they told her to call the school.
- Ms. Thalen thanked her for letting us know.
- Mrs. Sparks congratulated all the newly tenured teachers. She apologized to Mr. Texeira, Mr. Ellis and Mr. Lentini for not reserving her previously stated remarks of appreciation for this particular BOE meeting. She hoped the Beacon would accommodate her by publishing them. She read from a prepared statement in which she thanked Diane Armet for her valuable contributions to this district as both a teacher and administrator. How her youngest son was fortunate enough to have be taught by Brian Pope's unique style, which motivated his students to learn. She expressed her sincere thanks and appreciation to Mike Bowler for the many valuable contributions he made to Rocky Point as an educator, administrator, coach, and most importantly, as a kind and caring human being.

She also acknowledged Ms. Liebling and Ms. Finn for their outstanding work with children in the district.
