#### **EXECUTIVE SESSION**

At 4:58 p.m a motion was made by Michael Lisa, and seconded by Jessica Ward, to adjourn to Executive Session to discuss confidential legal and personnel issues.

Upon a motion made by Michael Lisa, and seconded by Jessica Ward, the Board adjourned Executive Session at 6 p.m. to attend the Budget Workshop presented by Christopher Van Cott.

At 6:17 p.m., upon completion of the Budget Workshop, a motion was made by Michael Lisa, and seconded by Jessica Ward, for the Board to return to Executive Session to continue their discussions regarding confidential legal and personnel matters.

The Board returned to Open Session at 7 p.m.

#### SUPERINTENDENT'S REPORT

Dr. O'Brien reviewed the recent mask requirement changes and thanked the community for their patience as they navigate through the daily updates. He added that a decision on the existing appeal was scheduled to be announced on March 2. Dr. O'Brien shared that they have consulted with legal counsel throughout the entire process and will continue to do so.

Dr. O'Brien stated that weekly COVID-19 update letters would no longer be sent as reported positive cases continue to decline. He shared that he, Mrs. Sullivan, Mr. Casswell and Mrs. Crossan had participated in the Longwood Legislative Workshop over the weekend. Assemblywoman Jodi Giglio and Senator Anthony Palumbo were also in attendance.

Mrs. Sullivan opened the floor to questions/comments regarding the agenda.

**BE IT RESOLVED**, that the final tally of votes shall be held at the Rocky Point High School, 82 Rocky Point-Yaphank Road, Rocky Point, New York at 9:00 PM on the evening of the election as soon thereafter as the election inspectors can certify as to the necessary information.

# XVIII MEMORANDUM OF AGREEMENT / ROCKY POINT SCHOOL-RELATED PROFESSIONAL ASSOCIATION

Upon a motion made by Ed Casswell, and seconded by Jessica Ward, the following resolution was offered:

**BE IT RESOLVED**, that upon the recommendation of the Superintendent of Schools, the Board of Education hereby approves a Memorandum of Agreement with the Rocky Point School-Related Professional Association to add two additional job titles and revise the language under Article IX; item G. All other terms and conditions of the 2020-2025 collective bargaining agreement between the District and the Rocky Point School-Related Professional Association shall remain the same.

All in favor – Motion carried 4-0

#### XIX PERSONNEL

Upon a motion made by Jessica Ward, and seconded by Michael Lisa, the following resolution was offered:

**BE IT RESOLVED**, that upon the recommendation of the Superintendent of Schools, the Board of Education accepts the attached Personnel changes.

All in favor – Motion carried 4-0

Once again Mrs. Sullivan invited the meeting attendees for questions/comments.

- Ms. Hyne thanked Mr. Lisa and Ms. Ward for voting yes to join the lawsuit against mask
  mandates. She inquired with Mrs. Sullivan and Mr. Casswell as to why they voted against
  it. Mrs. Sullivan advised that she felt the decision would be rushed without clarification
  with some particular language regarding a retainer. Mr. Casswell read a statement
  explaining that at each stage of the process they have coordinated with legal counsel and
  followed the law.
- Miss Luce shared her perspective as a student in support of the mask mandates. She expressed her concern for arguments amongst the students if personal choice is allowed.
- Mister Palifka explained his opposing view as a student in support of personal choice. He
  noted his positive experience on the day that the mandate was lifted. He added his
  concern of an impending vaccine mandate.
- Ms. Antonucci spoke about the likelihood of vaccine mandates in the near future. She also stated that legally they do not have to disclose all of the ingredients.
- Miss Sarlo read a statement and provided her views as a young student. She spoke about the negative effects and ineffectiveness of the mask mandate.

- Ms. Sarlo asked why the open trustee spot had not been filled. Mrs. Sullivan explained that the person they had in mind for the position was no longer available. She added that an additional election would've been very costly. Ms. Sarlo expressed the importance of a fifth Board of Education member to avoid a tie vote, especially in important situations such as the vote taken at the recent emergency meeting.
- Ms. Pinkenburg explained that many parents are in support of the mask mandate. She inquired with the Board of Education as to the basis in which the decision would be made to allow parental choice. Mrs. Sullivan advised that they would follow the law.
- Ms. Salz expressed the importance of evidence over public opinion and urged the Board to follow the science.
- Ms. Puckey reviewed some damaging effects such as speech issues and a lack of socialization as a result of the mask mandates.
- Ms. Hubert stated studies showing that cloth masks are not effective, therefore rendering the mandates ineffective. She cited the current non-socialization culture as a contributing factor to mental health issues.
- Ms. Baldi thanked the Board members who voted in favor of joining the lawsuit. She emphasized the importance of filling the open seat on the Board of Education, especially when difficult decisions need to be made. Ms. Baldi expressed her intentions of working together along with the support of the Board.
- Ms. Walsh inquired if a legislative committee would be created. Ms. Ward advised that there would be. Ms. Walsh thanked those Board members that voted in favor of joining the lawsuit and called for the resignation of those who opposed. She suggested that a second meeting could've been scheduled once the deadline was extended. Ms. Walsh advised the Board to do what's in the best interest of the children.
- Dr. Pinkenburg asked if the NYSED advised that the mask mandate should stay in effect, why they didn't abide by it. Dr. O'Brien stated that it was not enforceable.
- Mr. Baldi spoke about the ineffectiveness of the masks against small particles. He expressed the sentiment that those who are willing to sacrifice liberty to gain security would lose both.
- Ms. Van Horne stated concerns of psychological damage and shared that she
  homeschools her children because of the mask mandates. She commented that her child
  has been attending an indoor physical education class without masks and has not
  experienced any negative issues. Ms. Erin inquired as to why the community would no
  longer receive the emails containing the number of positive COVID-19 cases. Dr.
  O'Brien stated that it was due to the amount of positive cases being so low.

- Ms. Vergara asked if the constitution was part of the curriculum currently being taught in school. Dr. O'Brien confirmed it was. Ms. Vergara stated that children do not know how to fight for their rights so their parents speak out on their behalf. She added that there are consequences from the lack of contact.
- Ms. Borella questioned if contract tracing was still taking place. Dr. O'Brien stated that it
  was no longer required but does suggest that parents be contacted if their child is at risk.
  Ms. Borella stated that research takes time to be comprehensive. She added that she felt
  masks were not effective.
- Ms. Veit advised that masks are used to protect yourself from infection, and not others. She advocated for parental choice regarding mask usage.

There were no further questions/comments.
